Boarding Agreement

It is our policy to offer conscientious, affectionate and individual care to each pet left in our care. Your pet will be under the guidance of our Veterinarian during its stay. We will provide your pet with sanitary, clean and safe lodging. Guests will be fed regularly according to the owner's instructions. Medications will be administered as provided for and directed.

I further understand that all pets are received and released only during regular business hours or by special arrangements, as below:

Open 7 days
7 am – 7 pm Monday – Saturday
8 am – 6 pm Sunday

The following is understood and agreed upon:

- An agreement is required for each pet that you own.
- We offer various pet boarding accommodations, I prefer the following lodging for this particular pet as checked below:
- Stainless steel cages (small dogs/cats) \$16 per night _____
- 3' x 5' Standard Indoor Kennel Run \$20 per night _____
- 4' x 6' Standard Indoor Kennel Run \$26 per night _____
- 5' x 7' Luxury Themed Pet Suite \$36 per night _____
- 7' x 8' Luxury Themed VIP Suite \$49 per night _____
- Medication fee per day \$ 8 per day _____

LUXURY THEMED SUITES

- All pets are provided Purina Veterinary Diets during their stay. I may, at my option, provide my pet's food and/or treats for my pet's exclusive use. I will provide a packet of food and/or treats for each meal. We agree to feed the pet accordingly.
- I understand that my pet will be walked 2-3 times per day, outside. If you do not want your pet to go outside the building, please indicate below under special requests.
- I understand that in order for my pet to be in a Themed Suite it must be an indoor pet who is familiar with an indoor home environment, housetrained, vaccinated, spayed or neutered, free of worms, free of fleas/ticks, clean, toe nails trimmed.
- I understand that if my pet causes damage to the Themed Suite, I will be responsible for the repair and/or replacement to restore the Suite back to original.
 - Damage to Themed Pet Suite interior of room (door jams, raised bed platform, wall murals, plexi-glass, drywall, decorations, flooring, lighting, television, cushioned beds, bedding) will be the actual cost to repair the suite back to original, including replacing damaged items.
 - If staff sees pet causing damage, we may move the pet to standard boarding, at our discretion.
- I understand that extra walks, special staff time, extra treats, grooming, etc. is separate and separate prices per each item.
- I understand that there is a limit of 2 (similar sized) pets allowed per Suite, at our discretion.

STANDARD KENNEL RUNS

- The Standard Kennel Runs have a check-in and/or check-out time between 7am-10pm.
- Pets in standard kennels go outside each morning and afternoon into an outdoor kennel for exercise. Additionally, they may be hand walked by staff. If you do not want your pet to go outside the building, please indicate below under special instructions.
- I understand that in order for my pet to be in a Standard Kennel Run it must be vaccinated, free of worms, free of fleas/ticks, clean, toe nails trimmed.
- All pets are provided Purina Veterinary Diets during their stay. I may, at my option, provide my pet’s food and/or treats for my pet’s exclusive use. I will provide a packet of food and/or treats for each meal. We agree to feed the pet accordingly.
- I understand that if my pet causes damage, I will be responsible for the cost of repairs or replacement:
 - Damage to raised cots in the Standard Kennel Run is the price of the cot \$79.99.
 - Damage to Standard Kennel Run by digging, biting, chewing, scratching will be the actual amount it will cost to repair the run.
 - If you prefer to have none of our bedding with your pet or to bring your own, arrangements must be made at Check-in.
- I understand that if my pet behaves poorly, causes damage, barking excessively, will not eat or drink or urinate or have a bowel movement, that my designated emergency contact will be called to consult on the situation or to pick up my pet.
- I understand that on Check-in there is a 50% deposit due at that time.
- I agree that the remaining balance will be paid at Check-out.
